AN AUDIO-VISUAL PERFORMANCE CONCEIVED BY SYRIAN COMPOSER AND CLARINETIST KINAN AZMEH AND SYRIAN ARMENIAN VISUAL ARTIST KEVORK MOURAD, THE RESULT IS AN IMPRESSIONISTIC REFLECTION ON THE UNITY OF LOSS, LONGING, AND THE IMPACT OF TRAGEDY ON OUR SENSE OF 'HOME.'
